



Distinguished Program Award



Chapters planning to submit a Distinguished Program Award Application should read all information and the rubric carefully prior to preparing their application.

The **Distinguished Program Award** recognizes chapters *with outstanding programs that reflect the purposes of Alpha Delta Kappa (World Understanding, Excellence in Education, Altruism, Inclusion/Diversity/Equity) as well as programs that focus on personal enrichment. Distinguished programs are unique, creative, and/or innovative, and they promote attendance and involvement of members and prospective members.*

Why are chapter member attendance and prospective member attendance criteria? (These bullet points are for chapters to keep in mind as meetings and programs are planned, they are independent of the rubric.)

- Chapters should encourage good attendance at all meetings.
- Strong planning and communication between chapter members facilitate member attendance.
- Member attendance and participation in chapter meetings are important aspects of a healthy chapter.
- Good programs, along with strong participation, encourages the retention of members.
- Chapters should plan to invite prospective members to any chapter meeting.
- Inviting prospective members to multiple meetings provides an opportunity for them to observe a variety of programs and what it is like to be an Alpha Delta Kappa sister.

Eligibility:

Chapters may submit one program from June 1 to May 31 of the most recent program year.

Deadline:

Chapter entries are submitted online between August 1 – August 31.

Rules:

- Entries must be a maximum of 250 words (this is indicated by the word count provided by Microsoft Word.)
- Photographs, logos, or images (a maximum of 3 with one to be published) of the program or organization highlighted in the program should be included with the entry.
- Chapter programs with 15 points or more will be recognized at the regional level, and the chapter with the highest score will be designated the regional recipient.
- All entries become the property of Alpha Delta Kappa and may appear on the website and/or in the **KAPPAN**. The entries will not be returned.

Award:

Each regional recipient of the **Distinguished Program Award** will be featured in the **KAPPAN**. **All programs scoring 15 points or above will receive recognition** by being posted on the International Website.

Process for Submission:

- The online submission can be found on the International Website/AΔK CONNECT.
- Chapters are encouraged to review the criteria and the rubric prior to submitting their application. The rubric is included.
- Photographs, logos, or images (a maximum of 3 with one to be published) of the program or organization highlighted in the program should be included with the entry.
- Headquarters will forward each entry to the IVP for that region.

- Headquarters will notify by email the regional recipients, the S/P/N presidents, the IVPs, and the IVPM in December.

Process for Adjudication:

In September, the IVP shall share the submitted DPA applications with the region's RMC.

- If there is a conflict of interest with a submission (it is from the IVP or RMC's home chapter), the submission shall be forwarded to the International Vice President for Membership for adjudication using the rubric.
- Using the rubric, each IVP and RMC shall adjudicate the submissions separately to determine those programs receiving 15 or more points and report the scores on the DPA Scores Template.
- After adjudication, the IVP and RMC shall jointly review the regional submissions, determine the top-scoring admission, determine all submissions scoring 15 points or more, and forward to the coordinator at Headquarters by October 1.
- Headquarters shall notify by email the regional recipients, the S/P/N presidents, the IVPs, and the IVPM in December.
- The regional recipients shall submit an article for the **KAPPAN** by January 1.
